WHAT DOES Meridian Home Mortgage Corporation DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- **Social Security number** and **Account balances**
- **Assets** and **Credit history**
- **Credit scores** and **Income**

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share **Customers** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **Customers** personal information; the reasons **Meridian Home Mortgage Corporation** chooses to share; and whether you can limit this sharing.

How does Meridian Home Mortgage Corporation collect my personal information?

We collect your personal information, for example, when you

- **Apply for a loan** or
- **Give us your income information** or
- **Provide employment information** or
- **Provide account information** or
- **Show your driver's license**

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. **Your choices will apply to everyone on your account unless you tell us otherwise,**

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- **Meridian Home Mortgage Corporation does not share with our affiliates.**

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- **Meridian Home Mortgage Corporation does not share with nonaffiliates so they can market to you.**

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- **Meridian Home Mortgage Corporation does not jointly market.**

Other important information

CA Borrowers: We will not share your information with companies outside of Meridian Home Mortgage Corporation except for our everyday business purposes or with your consent.

Vermont Borrowers: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
